DAY 1: 6th MARCH, 2025 - INAUGURATION & PRELIMINARY ROUNDS

The inaugural session commenced with a traditional lamp-lighting ceremony, followed by the orientation of all participating teams from across India. The day began with registrations, an orientation session, a draw of lots, and the researchers' test. A total of 32 teams from various law universities and colleges registered for the competition. During the orientation, all the rules and regulations were discussed in detail to ensure clarity for the participants. The researchers' test was conducted immediately after the session, marking the official start of the competition.

DAY 2 : 7th MARCH, 2025 - PRELIMINARY ROUNDS, QUARTER-FINALS & CULTURAL NIGHT

The second day commenced with the preliminary rounds, followed by the draw of lots and quarter-finals. After rigorous rounds of competition, 8 teams qualified
