(11th August, 2025)

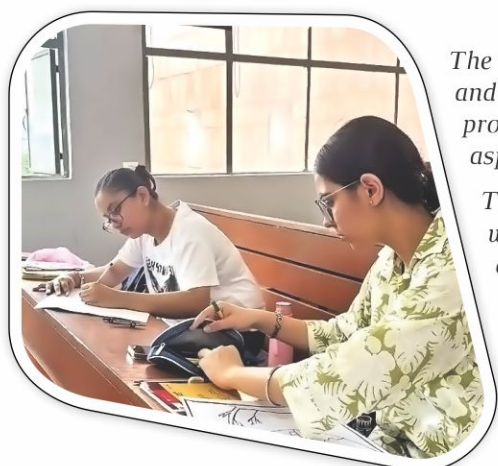

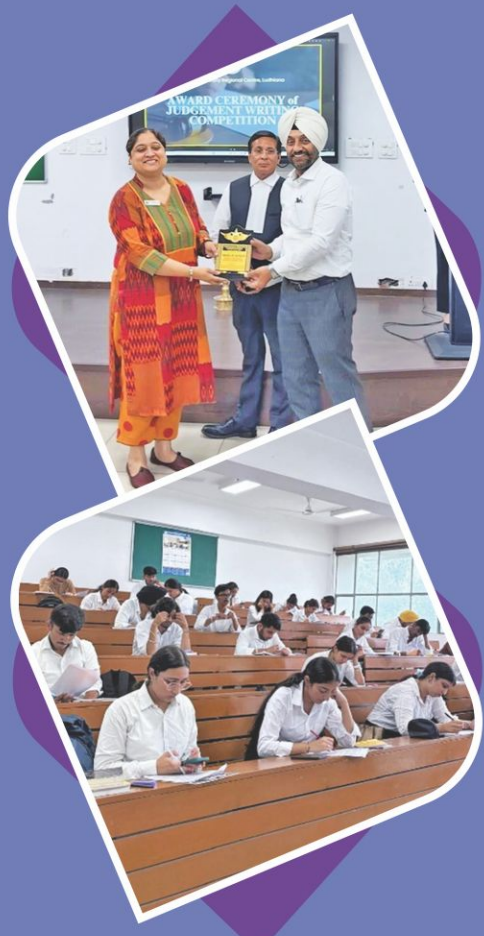
